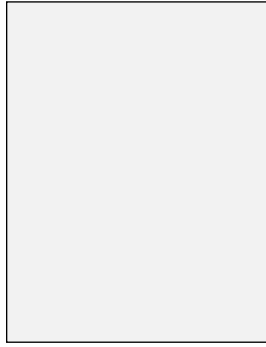

Notes to Application Form

1. The Application Form must be completed and signed by the authorized representative of the Applicant(s).
2. Application Form and supporting Documents to be submitted in triplicates in addition to soft copies on CD – Rom or Pen Drive.
3. National IDs should be valid at the time of submission of the Application Form. Acceptable IDs to be used are:
 - a. Driving Licence
 - b. Passport
 - c. Voter's ID Card
 - d. National Identification Card
4. Payment of the requisite application fee is to be made by Bankers' Draft to the National Communications Authority. *Note that payment is non-refundable.*
5. The Application Form is to be accompanied with certified True Copies of the Business Incorporation Documents.
6. The Business Plan should include the:
 - a. Organizational Structure of entity (include educational and technical background as well as experience of key personnel such as CEO/ Managing Director, Chief Technology Officer, Chief Information Officer, Chief Financial Officer, Chief Marketing Officer, etc as may be applicable).

SERVICE DEFINITION

- A. **Broadband Access Licence** "Broadband" means a high-speed wireless connectivity which allows users to access services at upload minimum rate of 256kbps with upload-download ratio of 1:4 (upload rate of 256kbps corresponds to download speed of 1024kbps). The Licensee is required to develop and operate a broadband network to provide Regional or Nationwide Broadband Access services
