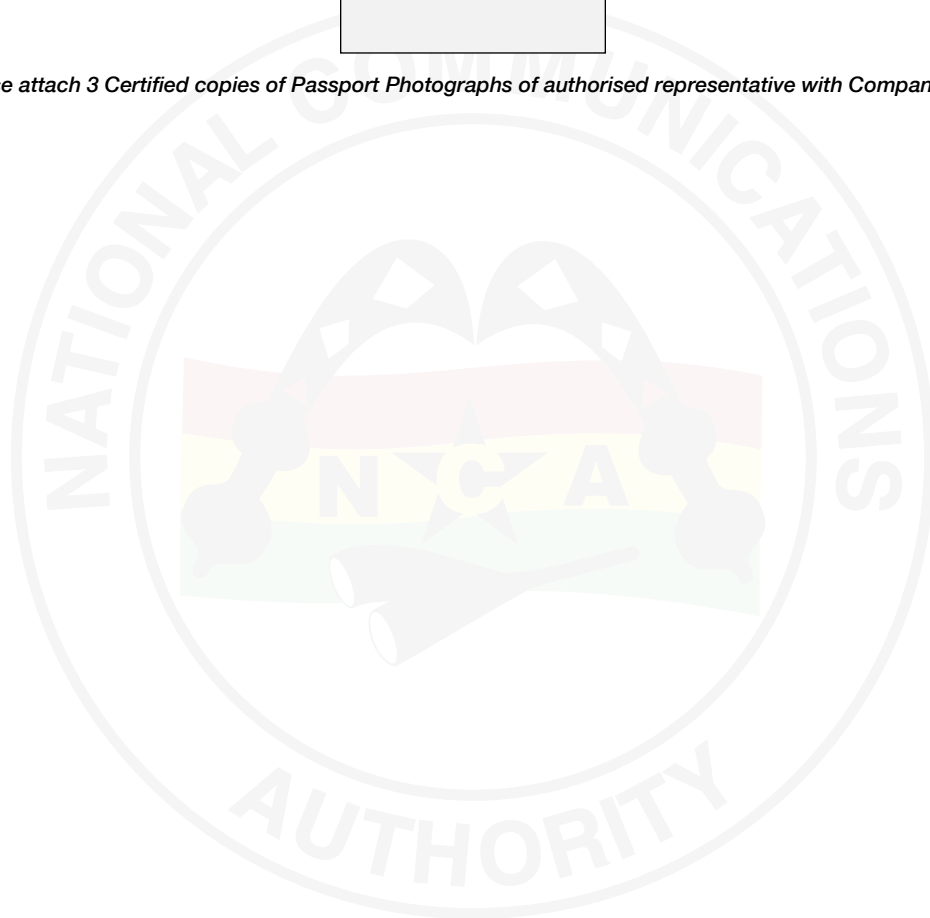

Notes/Guidelines to Application Form

1. The Application Form must be completed and signed by the authorized representative of the Applicant(s).
 2. Application Form and supporting Documents to be submitted in triplicates in addition to soft copies on CD – Rom or Pen Drive.
 3. National IDs should be valid at the time of submission of the Application Form. Acceptable IDs to be used are:
 - a. Driving Licence
 - b. Passport
 - c. Voter's ID Card
 - d. National Identification Card
 4. Payment of the requisite application fee is to be made by Bankers' draft to the National Communications Authority. Note that payment is non-refundable.
 5. The Application Form is to be accompanied with Certified True Copies of the Business Incorporation Documents.
 6. The Business Plan should include the:
 - a. Organizational Structure of entity (include educational and technical background as well as experience of key personnel such as CEO/ Managing Director, Chief Technology Officer, Chief Information Officer, Chief Financial Officer, Chief Marketing Officer, etc as may be applicable).
 - b. Audited Financial Statements for the past five (5) years of operation, to include:
 - i. Income Statement
 - ii. Balance Sheet
 - iii. Cash Flow Statement
 7. Entities are required to list in full all assigned spectrum (where applicable).
 8. Applicant is required to list in full all assigned blocks of numbers (where applicable).
 9. Applicant is required to list number of Inter-carrier Agreements between itself and other International Carriers since date of initial licence.
 10. Applicant is required to provide details of location of its gateway and connection point as well as routing arrangement with its contracted carriers as at date of submission of application.
