## NCA ENGAGES FM STATIONS ON FREQUENCY INTERFERENCE ISSUES

*Accra, 27th September, 2024*: The National Communications Authority (NCA) held a one-day consultative meeting with some FM station Authorisation Holders in Accra on 27th September 2024, at the NCA Tower, to address concerns regarding stations exceeding the permissible frequency deviation threshold.

In his welcome remarks, the Deputy Director for the Engineering Division, Mr. Bernard Amissah-Ocran, emphasized the importance of the gathering. He noted that the Authority had noticed persistent interference caused by some FM stations in Accra, which had raised concerns for the NCA. Given the ongoing challenges, Mr. Amissah-Ocran stressed that the NCA, under its strategic plan that prioritizes collaboration and partnership with stakeholders, saw it as necessary to invite the stations for deliberations.

The purpose, he explained, was to foster discussions on how to collectively address the issue and ensure the smooth functioning of broadcast frequencies, preventing further interference and enhancing overall service delivery. He underscored that collaboration between the NCA and FM stations is vital for maintaining broadcast standards and protecting the integrity of the airwayes

Kwame Baafuor Akoto, Senior Manager at the Engineering Division of the National Communications Authority (NCA), delivered a presentation on the role of the Broadcast Monitoring Centre in ensuring compliance with technical requirements outlined in FM stations' authorisation conditions.

He explained how the Centre is instrumental in tracking and monitoring the performance of radio stations, particularly in detecting instances where stations exceed permissible technical limits, such as frequency deviations. Mr. Akoto further highlighted the importance of adhering to these standards, as it ensures not only smooth and interference-free broadcasting but also the overall quality and reliability of FM transmissions.
