The National Communications Authority Amendment to User Guidelines: Dispute Resolution Committee (DRC)

Clauses 3.1 and 3.2 of The National Communications Authority-User Guidelines: Dispute Resolution Committee (DRC) gazetted on 13th August, 2024 is hereby amended and replaced with the following:

- 3.1 Membership of the DRC shall comprise:
- a) not less than twelve (12) persons (two of whom must be women) appointed by the Board, and
- b) a chairperson who must be a member of the Board
- 3.2 The DRC shall be duly empanelled for the hearing and determination of a matter by three (3) members (one of whom must be a lawyer) constituted by the chairperson.
