# NCA AND GFD LEAD NATIONAL CELEBRATION OF IDPD 2025 ON ASSISTIVE TECHNOLOGY AND INCLUSION

The National Communications Authority (NCA) and the Ghana Federation of Disability Organisations (GFD), in collaboration with the Ministry of Communication, Digital Technology and Innovations (MoCDTI) and the Ministry of Gender, Children and Social Protection (MoGCSP), joined the rest of the world on 3<sup>rd</sup> December, 2025, to celebrate the International Day of Persons with Disabilities (IDPD) 2025 at the NCA Tower in Accra under the theme “Assistive Technology: Empowering Lives, Advancing Inclusion.”

Delivering his remarks, the Minister of Communication, Digital Technology and Innovations, Hon. Samuel Nartey George, stated that the theme “reminds us that accessible technology is not a privilege; it is a human rights obligation, affirmed in the Persons with Disability Act (Act 715) and the UN Convention on the Rights of Persons with Disabilities (CRPD).

The Minister acknowledged that uneven access across regions, limited maintenance services, and digital platforms that still fall short of universal design requirements continue to hinder full inclusion. He stated that the Ministry recognises its central role in bridging these gaps. Hon. Sam George promised two important things: first, to improve accessibility on all government digital platforms by following global standards like the Web Content Accessibility Guidelines (WCAG); and second, to collaborate with the National Communications Authority (NCA) and telecom companies to create affordable data options, enhance customer service access, and encourage investment in technologies that include everyone.

As part of the Minister’s commitment, he announced that as the Ministry rolls out the One Million Coders Programme next year, 50,000 fully-funded training allocations have

been reserved for persons with disabilities. "The Ministry will ensure regional equity in the distribution of these slots by working closely with the Ministry of Gender and the Federation to identify eligible persons across all regions who will be able to undertake the training," he said.

Speaking at the event, Hon. Dr. Agnes Naa Momo Lartey (MP), Minister for Gender, Children and Social Protection, indicated that to ensure inclusivity, there must be sustained collaboration that actively dismantles barriers and creates an inclusive digital future where no one is left behind. "It's a collective and shared responsibility; hand in hand, we will walk this

path and ensure that inclusivity is a reality," she said.

The Acting Deputy Director-General in charge of Technical Operations at the NCA, Mr. Suleiman Salifu, stated that the enabling Act of the NCA, Act 769, enjoins the NCA, as part of its best practices, to perform its functions having regard for the needs and interests of persons with disabilities, the elderly, low-income earners, and the vulnerable.

"It is in this light that at an inaugural stakeholder engagement a few weeks ago with mobile terminal device manufacturers and dealers to design a new minimum specification for

terminal devices for Ghana by 2026, one of the key and prominent minimum specifications that every terminal device should have before being type-approved and permitted entry into Ghana is an accessibility feature," Mr. Suleman Salifu remarked.

A panel discussion on fostering disability-inclusive societies to advance social progress, moderated by renowned disability activist, Madam Patience Atipoka Atuah, enriched the event with insightful perspectives.

Speaking on behalf of the GFD, Mr. Joseph Atsu Homadzi expressed his gratitude to the President, His Excellency John Dramani Mahama, as well as to partners and donors, for

the continuous support extended to the GFD over the years in championing the cause of persons with disabilities in Ghana. He further urged other institutions to follow this example and ensure that disability inclusion is integrated into every aspect of national development.



# NCA ENGAGES ISPs ON LICENSING RECLASSIFICATION AND REVIEW OF FEES

The National Communications Authority (NCA) has held a stakeholder engagement with Internet Service Providers (ISPs) to provide clarity on the reclassification of the ISP licensing regime and the revised Schedule of Fees and Charges. The engagement took place at the NCA Tower on 17<sup>th</sup> December, 2025.

Delivering the keynote address, the Acting Deputy Director-General in charge of Technical Operations at the NCA, Mr. Suleiman Salifu, explained that the ISP landscape has

evolved significantly over the years, driven by new business models, expanding network footprints, and increased demand for bandwidth, cloud services, and content delivery.

He noted that the existing three-tier categorisation of ISPs, that is Nationwide, Rural, and Hotspot, had become inadequate to reflect current operational realities. To address this, the Authority has introduced additional categories, including Regional ISP, Internet Reseller, and Internet Network Provider (IP Transit), to ensure

better alignment between licensing obligations and the scale of operations.

Mr. Salifu further highlighted the introduction of a 0.5 percent Net Revenue Regulatory Fee, which replaces the previous flat fee structure. According to him, the new approach aligns with international best practice and promotes fairness by linking regulatory fees more closely to operators' commercial activities.

A technical presentation was delivered by Mr. Kwame T. Larnor, Deputy Manager of the Engineering Division, who provided detailed explanations on the new ISP categories, licensing requirements, and compliance expectations under the revised framework. The presentation was followed by an interactive session during which participants sought clarification on

implementation timelines, licence migration and fee computation.

The engagement also underscored the Authority's ongoing efforts to promote local peering and efficient internet exchange. Participants were briefed on a framework under development to encourage local interconnection at Internet Exchange Points such as the Ghana Internet Exchange (GIX) and the Accra Internet Exchange (Accra-IX), aimed at reducing latency, lowering costs and improving quality of service.

The engagement forms part of the Authority's efforts to strengthen regulatory transparency and ensure industry alignment with recent reforms, following a review of fees and charges that had remained unchanged for approximately nine years.

# GHANA AND BURKINA FASO SIGN MoU TO DRIVE AFFORDABLE CROSS-BORDER MOBILE COMMUNICATION

The National Communications Authority (NCA) of Ghana and the Autorité de Régulation des Communications Électroniques et des Postes (ARCEP) of Burkina Faso have signed a Memorandum of Understanding (MoU) on Free Roaming between the two countries. The signing ceremony took place on 21<sup>st</sup> November, 2025, as part of the Digital Week event in Ouagadougou, where Ghana participated as Guest of Honour.

This MoU establishes the framework for technical and regulatory collaboration, paving the way for seamless mobile communication across borders. Mobile subscribers travelling between the two countries will be able to make calls, send messages, and use data services without incurring additional roaming charges. With this development, Ghana has successfully

concluded free roaming arrangements with all its neighbouring countries.

Speaking at the signing ceremony, the NCA's Deputy Director General for Technical Operations, Mr. Suleman Salifu, emphasised that the collaboration reinforces the longstanding relationship between the NCA and ARCEP Burkina Faso. He reaffirmed Ghana's commitment to deepening regional connectivity and ensuring that communication services become more accessible, affordable, and seamless for citizens.

Mr. Salifu further expressed confidence that the agreement will further strengthen institutional cooperation and lay the foundation for more joint initiatives in the future.

On his part, ARCEP's Executive Secretary, Patrice Compaoré, indicated that the elimination of the roaming charge will allow Burkinabé travelers in Ghana, as well as Ghanaian nationals in Burkina Faso, to communicate at rates similar to those charged in their countries of origin. He noted that this agreement would help strengthen bilateral cooperation by facilitating exchanges and communication between the two countries.

Regulators and Mobile Network Operators (MNOs) of both countries will continue to work collaboratively towards the implementation and testing of the agreed roaming services prior to

the launch of the service in April 2026. The NCA takes the opportunity to acknowledge the guidance of the Minister for Communication, Digital Technology and Innovations, as well as the cooperation of MNOs in ensuring the successful conclusion of this agreement.

In attendance were Hon. Samuel Nartey George, Ghana's Minister for Communication, Digital Technology and Innovations; Dr. Aminata Zerbo-Sabané, Burkina Faso's Minister of Digital Transition, Posts and Electronic Communications; and Mobile Network Operators of both countries.

# NCA COLLABORATES WITH SEC AND NMC TO EDUCATE FM AND TELEVISION BROADCASTING STATIONS ON FRAUDULENT INVESTMENT SCHEMES

On 16th December, 2025, the National Communications Authority (NCA), in collaboration with the Securities and Exchange Commission (SEC) and the National Media Commission (NMC), engaged FM and Television broadcasting stations at the NCA Tower as part of efforts to strengthen public protection against fraudulent investment schemes and unethical broadcast content.

The engagement aimed at educating broadcasters on their responsibility in vetting advertisements and promotional content, particularly those related to investment opportunities that may expose the public to financial harm.

Speaking on behalf of the Acting Deputy Director-General in charge of Technical Operations at the NCA, Mr. Suleman Salifu, the Head of the Engineering Division at the NCA, Mr. Bernard Amissah-Ocran, emphasised the collective responsibility of regulators and broadcasters in safeguarding the integrity of the airwaves.

“As regulators and operators, we are collectively

entrusted with ensuring that the airwaves remain safe, credible, and in the public interest. This includes exercising vigilance over broadcast content, particularly advertisements and promotions that may expose the public to financial harm,” he stated.

He described the engagement as both timely and necessary, noting that it provided a platform for the Securities and Exchange Commission (SEC) to educate broadcasters on the indicators and regulatory implications of fraudulent investment schemes. The forum also reinforced the importance of inter-agency collaboration among the NCA, SEC, and the National Media Commission (NMC) in addressing cross-sectoral challenges.

Delivering his remarks, the Executive Secretary of the National Media Commission (NMC), Mr. George Sarpong, underscored the importance of strengthened collaboration among regulators and broadcasters in addressing emerging challenges within the media space. He charged broadcasters to actively use their platforms to educate the

public, particularly on issues that pose risks to society. Mr. Sarpong further emphasised the need to establish formal fora through which regulators can collectively address emerging threats and enhance coordinated responses across sectors.

The Deputy Director-General at the Securities and Exchange Commission (SEC), Mr. Mensah Thompson, noted that fraudulent investment schemes not only undermined investor confidence but also eroded public trust in

legitimate financial and media institutions. He further highlighted that the rapid growth of new media and digital platforms, while offering opportunities for innovation and economic growth, had also introduced new risks. He stated that the engagement formed part of ongoing efforts by the NCA, NMC and SEC to strengthen regulatory oversight, enhance inter-agency collaboration, and protect the public from financial and digital risks within Ghana's evolving media landscape.


